Objectives

Master of Social Science Gerontology programme is designed for professionals who are interested in developing a career specialized in psychogeriatric care at both policy/programme and clinical intervention levels.

Students will be equipped with values, knowledge and skills regarding the provision of psychogeriatric care for older adults with a global vision and local focus.

Curriculum

Candidates are required to complete 6 compulsory courses, and 4 elective courses or 2 elective courses with a dissertation.

Objectives

The ultimate objective is to facilitate aspiring and established healthcare and social service professionals to develop the necessary knowledge and skills to become competent clinical practitioners, administrative and/or clinical supervisors in their respective fields of work.

Curriculum

Candidates are required to complete 5 compulsory courses, and 5 elective courses or 3 elective courses with a dissertation.

Dr. Vivian LOU
MSocSc (Gerontology)

Dr. Vivian Lou has studied widely on family caregiving and its health impacts. Examining Chinese family caregivers' mental health impacts in both Shanghai and Hong Kong was a pioneer study that generated high impact publications. Recently, Dr. Lou's study extended to examining positive and/or resilient capacity of the family caregiving in Chinese context including studying secondary caregivers, social support, and roles of domestic helper.



Dr. Frances LAW
MSocSc (Social Service Management)

Dr. Frances Yik Wa Law is a Registered Social Worker (RSW) in Hong Kong. She has extensive experiences in piloting and managing innovative research studies in suicide prevention and self-harm, mental health care services and issues in the community. She has made significant contributions to integrating social work practice and evidence-based research. Frances has authored or co-authored over 40 academic peer-reviewed articles and book chapters. She was trained and had practiced as a social worker in Hong Kong and California, USA in the fields of children, youth and family services, training for trainers, service development, strategic organizational development, and fundraising for innovative projects. Her teaching specialties include social service management and social work research.

Professor Daniel WONG
MSocSc (Mental Health)

Professor Daniel Wong is a certified cognitive therapist and a Fellow of the Academy of Cognitive Therapists, a mental health social worker and clinical psychologist. He is a Professor of the Department of Social Work and Social Administration, The University of Hong Kong and teaches mental health social work and counseling, including CBT. He has rich clinical experience and is a popular trainer and speaker in CBT and mental health issues.



Dr. Ben LAW
MSocSc (Social Work - Integrated Practice with Young People Stream)

Dr. Ben Law is the Senior Lecturer in Department of Social Work and Social Administration of The University of Hong Kong. He teaches in the areas of youth social work, disability and social divisions. His research areas include youth volunteerism, positive youth development, problem behavior, school social work and existential mental health. Before joining the university, he has worked in school social work, family social work and special educational needs project for more than 15 years. His work appears in Adolescence, Social Indicators Research, and Research on Social Work Practice.
